I understand I must inform the Court in writing within (7) days if there is a change in the above-named defendant's address. I understand my obligation does not end when the above-named defendant turns 17. It ends only when the judgment is fully satisfied or the case otherwise reaches final disposition. I also understand that my failure to keep the Court informed of changes in the above-named defendant's residential address could result in my arrest, and I may be charged with a Class C misdemeanor punishable by a fine of up to \$500.00. I understand that if the defendant does not appear with a parent or legal guardian at any future scheduled hearings and/or trial regarding the above referenced case, FAILURE TO APPEAR CHARGES MAY BE FILED AGAINST THE PARENT/LEGAL GUARDIAN that is referenced below. I further understand that it is my responsibility to notify the court as to any court orders that affect my status as parent/legal guardian.
